MODESTO, CALIFORNIA, NOVEMBER 15, 2025 — First in a fascinating new series of *Historic Record Wall Calendars*, this thirteen-month Manzanar 2026 wall calendar, together with its Prologue and Epilogue, succinctly and dramatically recounts the collective experience of over 10,000 U.S. residents of Japanese ancestry who were exiled from their homes on the West Coast and parts of Arizona, then unjustly incarcerated at California's remote, high desert camp known as Manzanar.



Through its engaging narratives, fact-filled captions, and deeply affecting period photographs, buyers of the calendar will be taken on a year-long journey examining the tragedy of then-President Franklin Roosevelt's executive order that ripped over 126,000 law-abiding Japanese and Japanese Americans from their homes and their previous lives, simultaneously stripping them of their

freedom, property, livelihoods, and human dignity... all without the due process of law that was their constitutional right.

Each calendar month focuses on a different aspect of camp life at Manzanar, as well as some of the coping mechanisms detainees employed to recover a sense of normalcy while living within its barbed wire confines. Calendar narratives and stunningly arrayed photographs (see examples on these two pages) portray Manzanar's men, women, and children at work and leisure, during their studies and at worship,

attending choral rehearsals and dances, engaging in basketball practice and base-

ball tournaments, taking care of their health, relaxing with family or neighbors both outdoors and inside their cramped, tarpaper-clad barracks — in short, aspiring to the kind of lives enjoyed by people outside Manzanar.

Ideal for history buffs, teachers and students, or anyone else who wants to honor the past as it really happened.

The calendar's Epilogue goes on to document the December 1944 Supreme Court decision declaring Roosevelt's executive order unconstitutional, while providing brief but welcome examples of former incarcerees picking up the pieces of their devastated lives as best they could, eventually leading to the Manzanar war relocation center being declared a National Historic Site.
